RECREATIONAL FACILITIES INCLUDING BASEBALL FIELDS, FOOTBALL FIELD, CONCESSION STAND, BENCHES, BLEACHERS, ETC. PROPERTY LEASED BY LENAPE VALLEY RECREATION COUNCIL. PARKING ON-SITE.
- 7 LINDENFIELD PARKWAY (N. MAIN STREET & LINDENFIELD PARKWAY)**
OPEN SPACE/CENTER ISLANDS WITH WALKWAY, TREES.
- 8 PATRIOT DRIVE (PARK AVENUE)**
OPEN SPACE. SIDEWALK, TREES, ADJACENT TO NORTH BRANCH OF NESHAMINY CREEK.
- 9 BIRCHWOOD DRIVE**
OPEN SPACE/DETENTION BASIN, NATURAL AREA WITH WILDFLOWERS, BIRDS, BUTTERFLIES, WILDLIFE.

- 1 KRUPP PARK (40 N. MAIN STREET)**
GAZEBO, FLOWER BEDS, PATHS, BENCHES, PICNIC AREA, FISHING, PHOTO OPPORTUNITIES, WEDDING BY PERMIT. BRIDGE OVER NESHAMINY CREEK TO KELLY PARK. PARKING IN BOROUGH HALL LOT, 40 N.MAIN ST.
- 2 KELLY PARK (40 N. MAIN STREET)**
WOODED AREA, PICNIC AREA, FISHING, VIEWS OF KRUPP PARK ACROSS BRIDGE. PARKING IS OFF OAK AVENUE, WITH PATH INTO PARK. FOOTBRIDGE TO KRUPP PARK.
- 3 J. CLYDE DERSTINE MEMORIAL PARK**
PICNIC AREA, FISHING IN NESHAMINY CREEK. ACCESS TO PARK FROM SKYLINE DRIVE CUL-DE-SAC. TRAIL TO OAK AVENUE.
- 4 FAIRVIEW PARK (33 OAK AVENUE)**
OPEN SPACE INCLUDING WOODED AREA WITH STREAM.
- 5 HOLLAND PARK (MANOR LANE)**
OPEN SPACE. ACCESS OFF OF HOLLAND DRIVE.

- 10 CHESTNUT STREET PARK**
OPEN SPACE, PLAYING FIELDS, WALKING TRAIL, TABLES, BENCHES, TREES, BUTTERFLY GARDEN. PARKING IN CHESTNUT STREET LOT.
- 11 BRIDGEVIEW PARK (OLD BUTLER AVE.)**
BENCH OVERLOOKING CREEK, PICNIC AREA, FISHING. PARKING AT END OF OLD BUTLER AVE. (SPUR OFF RT. 202)
- 12 CHALFONT COMMUNITY PARK (BLUEJAY) (CARDINAL ROAD)**
PLAYGROUND EQUIPMENT, SWINGS, MERRY-GO-ROUND, JUNGLE GYM, BASKETBALL COURT, BENCHES, WOODED PICNIC AREA, WOODED NATURE TRAIL, OPEN SPACE. ACCESS AND PARKING AT END OF CARDINAL RD.
- 13 LENAPE BIKE AND HIKING PATH**
PAVED PATH ALONG THE NESHAMINY CREEK AND WETLANDS AREA, FISHING, WATERFOWL, WILDFLOWERS, NATURAL AREA. ACCESS AND PARKING AT LANDING WAY AND ON LENAPE LANE.
- 14 TWIN STREAMS PARK (10 W. BUTLER AVE.)**
PAVED PATH ALONG THE NESHAMINY CREEK AND WETLANDS AREA, FISHING, WATERFOWL, WILDFLOWERS, NATURAL AREA.
